WHAT ARE COOKIES

As with nearly all professional websites, this site uses cookies, which are small files downloaded to your computer or device, to enhance your experience. This Cookies Policy describes what information cookies collect, how we use them, and why we sometimes need to store these cookies.

We will also explain how you can prevent these cookies from being stored, though this may downgrade or limit certain elements of the site's functionality.

In Simple Terms:

- Cookies are small text files stored on your device when you visit our Website
- They help us remember your preferences and understand how you use the site
- They enable certain features and improve your overall experience
- Most websites use cookies, and they are essential for modern web functionality

HOW WE USE COOKIES

We use cookies for various reasons detailed below. Unfortunately, in most cases, there are no industry-standard options for disabling cookies without completely disabling the functionality and features they add to this site.

It is recommended to leave cookies enabled if you are not sure whether you need them or not, as they may be used to provide services or features that you use.

Primary Uses:

Essential Functionality:

- Enable core website features (e.g., page navigation, secure access)
- Remember your preferences and settings
- Maintain your session when you connect your wallet

Analytics and Performance:

- Understand how visitors interact with the Website
- Identify which pages are most and least popular
- Analyze traffic patterns to improve site performance
- Track errors and diagnose technical issues

User Experience:

- Remember your language and regional preferences
- Provide personalized content and recommendations
- Ensure consistent experience across visits

Security:

- Detect and prevent fraudulent activity
- Protect against automated abuse (e.g., bots)
- Verify legitimate users

DISABLING COOKIES

You can prevent the setting of cookies by adjusting the settings on your browser (see your browser's Help section for instructions).

Important: Be aware that disabling cookies will affect the functionality of this and many other websites you visit. Disabling cookies will usually result in:

- Certain features and functionality being disabled
- Reduced or limited user experience
- Inability to save preferences or settings
- Potential issues with wallet connection or token purchase functionality

Therefore, it is recommended that you do not disable cookies unless absolutely necessary.

How to Manage Cookies in Your Browser:

Google Chrome:

1. Open Chrome and click the three-dot menu (top right)
2. Go to Settings > Privacy and Security > Cookies and other site data
3. Choose your preferred cookie settings

Mozilla Firefox:

1. Open Firefox and click the three-line menu (top right)
2. Go to Settings > Privacy & Security
3. Under "Cookies and Site Data," choose your preferences

Safari:

1. Open Safari and go to Preferences (Safari menu)
2. Click Privacy tab
3. Manage your cookie settings under "Cookies and website data"

Microsoft Edge:

1. Open Edge and click the three-dot menu (top right)
2. Go to Settings > Cookies and site permissions
3. Manage your cookie preferences

Mobile Browsers:

- Settings may vary; consult your browser's help documentation

THE COOKIES WE SET

Essential Cookies

Session Cookies:

- Purpose: Maintain your session as you navigate the Website
- Duration: Deleted when you close your browser
- Why necessary: Enable basic site functionality and security

Wallet Connection Cookies:

- Purpose: Remember your connected wallet address during your session
- Duration: Session-based or persistent (depending on your choice)
- Why necessary: Enable participation in the token presale

Site Preferences Cookies:

- Purpose: Remember your preferences for how the site operates when you use it (e.g., language, region, display settings)
- Duration: Varies (typically 1 month to 1 year)
- Why necessary: Provide a personalized experience without requiring you to reset preferences on each visit

Forms and Interaction Cookies**Form Data Cookies:**

- Purpose: When you submit data through a form (e.g., contact forms, support requests), cookies may be set to remember your user details for future correspondence
- Duration: Varies (typically 30 days to 1 year)
- Why used: Improve user experience by pre-filling forms with your information

Email Newsletter Cookies:

- Purpose: Remember if you are already subscribed to our newsletter or email updates, and whether to show certain notifications
- Duration: Varies (typically 1 year)
- Why used: Avoid duplicate subscription requests and provide relevant notifications

THIRD-PARTY COOKIES

In some cases, we use cookies provided by trusted third parties. The following section details which third-party cookies you might encounter through this Website.

Google Analytics

Provider: Google Inc.

Purpose:

- This site uses Google Analytics, one of the most widespread and trusted analytics solutions on the web
- Helps us understand how you use the site and how we can improve your experience
- Tracks information such as:
 - How long you spend on the site
 - Which pages you visit
 - How you arrived at the site (referral source)
 - General demographic information (location, device type)

Data Collected:

- Anonymized and aggregated user behavior data
- Does not collect personally identifiable information in most cases

Duration: Varies (typically up to 2 years)

Third-Party Analytics Services

Purpose:

- We may use additional third-party analytics services to track and measure usage of this site
- Helps us understand user behavior, identify popular content, and improve the site
- May track metrics such as page views, session duration, bounce rate, and conversion rates

Why used:

- Produce engaging content and optimize user experience
- Make data-driven decisions about site improvements

Duration: Varies by provider

Testing and Optimization Cookies

Purpose:

- From time to time, we test new features and make subtle changes to the way the site is delivered
- A/B testing cookies ensure you receive a consistent experience while we test different versions of pages or features
- Help us understand which optimizations and features users appreciate most

Why used:

- Improve site performance and user experience
- Test new functionality before full rollout

Duration: Varies (typically 30-90 days)

Purchase and Conversion Tracking Cookies

Purpose:

- As we sell tokens during the presale, it's important for us to understand statistics about how many visitors actually make a purchase
- These cookies track conversion rates and user behavior leading to purchases
- Help us measure the effectiveness of marketing campaigns

Why used:

- Make accurate business predictions
- Monitor advertising performance and costs
- Optimize marketing spend to ensure the best value
- Understand user journey from visit to purchase

Data Collected:

- Number of purchases
- Purchase amounts (in aggregate)
- Conversion rates
- Referral sources for successful purchases

Duration: Varies (typically 30-90 days)

Social Media and Marketing Cookies

Purpose:

- If you share our content on social media or arrive at our site via a social media platform, cookies may be set by those platforms
- Enable social sharing features and track engagement
- May be used for retargeting and personalized advertising

Third-Party Platforms:

- Twitter/X
- Telegram
- Discord
- Facebook
- LinkedIn
- Others as applicable

Important: These cookies are controlled by the respective third-party platforms. Please review their privacy policies for more information.

Duration: Varies by platform

CATEGORIES OF COOKIES

1. Strictly Necessary Cookies

Purpose: Essential for the Website to function properly. Cannot be disabled without severely affecting site usability.

Examples:

- Session management cookies
- Security cookies
- Load balancing cookies

User Control: Cannot be disabled if you want to use the site.

2. Performance and Analytics Cookies

Purpose: Collect information about how visitors use the Website (e.g., which pages are visited most often).

Examples:

- Google Analytics
- Heatmap and session recording tools
- Error tracking and diagnostics

User Control: Can be disabled, though this limits our ability to improve the site based on user feedback.

3. Functionality Cookies

Purpose: Remember your preferences and provide enhanced, personalized features.

Examples:

- Language and region preferences
- Display settings (e.g., dark mode)
- Wallet connection preferences

User Control: Can be disabled, but will result in loss of personalized features.

4. Marketing and Targeting Cookies

Purpose: Track your activity across websites to deliver personalized advertisements and measure campaign effectiveness.

Examples:

- Retargeting cookies
- Social media platform cookies
- Advertising network cookies

User Control: Can be disabled through browser settings or opt-out mechanisms provided by advertising networks.

YOUR CHOICES AND RIGHTS

Managing Cookie Preferences

You have the right to decide whether to accept or reject cookies. You can exercise your cookie rights by:

1. **Browser Settings:** Adjusting your browser settings to block or delete cookies (see "Disabling Cookies" section above)
